
## Multi-actor plan against crime for the municipality of Elbasan

The Action Plan includes the set of measures to address the risks and factors identified according to the areas of responsibility of the "triangle" institutions and other public and non-public actors. It is a complementary tool for improving and strengthening interinstitutional cooperation and addressing the issues identified during the consultation meetings.

The plan aims to achieve the following objectives:

**Objective 1**. Capacity building and multi-actorial investment which involves citizens for crime prevention in the municipality of Elbasan;

**Objective 2.** Reducing the intensity and gradual elimination of phenomena that threaten public safety and especially vulnerable groups;

**Objective 3.** Investing in a cyclical "triangle" approach which is updated on a 6-month basis;

The issues discussed at this meeting and the issues of public order and safety identified over the years by various public and civic actors in the municipality of Elbasan, were taken into consideration for the preparation of this plan. IDM in constant consultation with experts from the municipality, police, prosecution, education directorate but also other civil society actors worked to draft a multistakeholder plan for public order and safety.

This plan will be discussed and approved at the next Local Public Safety Council, while it was agreed that six months after the approval of this plan, the leaders of the "triangle" institutions in communication with citizens will assess the implementation of the plan and its objectives on an ongoing basis. This experience as mentioned above will be repeated every six months.

Defining measures at "high", "moderate", and "low" priority does not indicate a differentiated attitude but draws attention on the issues that have the highest risk at the moment. Consistently, depending on the achievements on the basis of the work performed and the evaluation of the actors, the intensity of the measures is subject to changes every six months.


